



INTRODUCING OUR NEW CHAIR

John Tierney has been in the United States since October 1974 and first became a member of the American Chemical Society in 1983. He has served the Philadelphia Section as a member of the Board of Directors initially from 1985-1992 until his return in 2004. In 2007 he was elected Secretary for a two-year period. During his early tenure with the Philadelphia Section, he also served as chair of the **Education Committee and has** been involved in the local section's efforts to get students involved in the Chemistry Olympiad.

John grew up in London, England and attended St. Clement Danes School (famous for the line in the children's nursery rhvme "Oranges and Lemons say the Bells of St. Clements." Upon leaving (you do not graduate from a K-12 school in the UK), John attended Reading University where his degree was in chemistry with mathematics. On graduating from Reading University in 1971 he went on to do a masters degree in physical organic chemistry at the Hatfield Polythechnic - now the University of Hertfordshire. After a year working for Diversey in Cockfosters. London as a



detergent chemist, he decided to go back to school to get a PhD. Two criteria were required for the destination. The first was that the schools applied to had to have a PhD program, and the second was that there was a large body of rowable water within easy reach. Hence, John landed in Philadelphia and when he was not in the labs at Temple University, he could always be found on the Schuylkill.

After graduating from Temple in 1980, John was hired as a visiting assistant professor and oversaw the organic chemistry labs, and taught a lecture section in organic chemistry. In fall 1982, John moved to Kean College (now University) as an assistant professor, but he only lasted a year at that institution because the commute to the Schuylkill each day proved to be somewhat taxing. In fall 1983, he was hired as an assistant professor at Penn State Delaware County (now the upscale Brandywine Campus).

1996 he was promoted to associate professor and full professor in 2007. His research is in the area of sulfur nitrogen heterocycles, and much of the published work has been accomplished with undergraduate students. John also has interests in pedagogy and in the area of human sweat; a link to his rowing world where he has produced a lot of the aforementioned fluid.

John lives in Chester County, PA with his wife Ann, and children Sean Liam (18), Emma Christine (16) and Elaine Brigid (11). John met his wife Ann at the Vesper Boat Club where they both rowed. Ann has moved on from rowing and is now an accomplished and much medaled runner. John still gets out on the river as much as possible, and enjoys rowing with the many characters on the Schuylkill.

"Athbhliain faoi mhaise daoibh!" as my parents would say. Translation: "A prosperous new year to you all!"

I should begin by telling you that the last time I wrote anything on a regular basis it was for a much less prestigious newsletter than the Cata*lvst*. The newsletter was called *The Rudder* – a rag put out by the Vesper Boat Club, on Boathouse Row, in Philadelphia. In addition to this, the last time I had a leadership role of any note was that of Team Leader for the US Rowing Team at the Pan Am Games in 1991, and the Barcelona Olympics in 1992. As Team Leader, I was appointed and not elected, as is my present situation as Chair of the Philadelphia Section. Strategic Alliances for Consultants

Abstract: A strategic alliance is an agreement between two business entities that provides compensation to each for helping the other party get new business. This is particularly relevant for independent consultants and small consulting firms, where one party may encounter a project that it cannot handle, but which would be a good fit for the other party. We will discuss how these agreements might be structured, and relate successes and failures in these types of arrangements. Several internet sites facilitate this, in addition to interpersonal, ad hoc or formal arrangements. Consultants with experience with strategic alliances, or with an interest in setting them up, are encouraged to attend and contribute to the discussion.

The meeting was called to order by Chair J. Summers-Gates at 4:10 PM.

A motion was made (D. Cichowicz) and seconded (A. DeMasi) to accept the minutes of the April meeting as amended. The motion was unanimously approved.

OFFICER REPORTS:

Chair (J. Summers-Gates): Since D. Cichowicz has taken over the position of Treasurer there is a need to fill his seat on the board. The September meeting will take place at Yards Brewery (September 16, 2010). Local Section Innovative Projects Grant Program is available from National at:

The Innovative grants applications are due June 30.

Bill Smith reported the distribution of 210 of the Section's Merck indices. They were donated to students and teachers in Montgomery and Bucks counties as well as students who took the Delaware Valley Science Council's annual scholarship examinations.

Chair Elect (J. Tierney): Would like the Section website updated and utilized more for submission of award dossiers, etc., made secure with SECURE link to Google Docs. The website should be updated and maintained by a new outside webmaster. A quote of \$75/hr. for the redesign was mentioned. The topic will be brought up and discussed further by the Publications Committee.

As per financial constraints, the need to make cuts in budget was brought up. One place where cuts could be made is to no longer pay for a professional photographer at many events. The concern of the need for someone to be designated to the job of taking photographs at each Section event was discussed. It was also mentioned that the Section Office has an older digital camera and it was offered for use at Section events.

Online elections were discussed. J. Crawford mentioned using SurveyMonkey, as a secure

means of online elections. It was suggested to use a postcard mailing to alert Section members of the availability of both the online and paper ballot options. The bio-sketches of the candidates would be published on the website. The concern of the current wording regarding online voting and publishing the election materials on the website in the by-laws was mentioned. The need to check with National was brought up. The urgency of starting work on online elections was also mentioned. J. Tierney agreed to look into the matter. Secretary (M. Prushan): no

Treasurer (D. Cichowicz): A motion was made and seconded (V. Tortorelli) to accept the Treasurer report. The motion was unanimously approved.

Finance Committee (V. Tortorelli, J. Falcone, A. DeMasi, J. Tierney and D. Cichowicz): made financial recommendations for the Section.

- (a) Ask for reality for each budget item (i.e., Council Affairs Committee) in future budgets each committee/group chair is responsible for preparing a committee report each year that contains justification for expenditures both present and future—need to specifically state what money will be used for.
- (b) Ask those responsible for budget line items to report where cuts can be made between now and December to prevent finance audit and budget forced cuts.

- (c) FBA/IVBT needs to be re-instituted as National will no longer handle our investments, Jim Falcone to head group to be determined.
- (d) If we use the \$28K budgeted this year, no money will be available next year if the current formula is followed.

The general feeling of the Finance Committee was to make cuts if programming is to continue.

The possibility of PAGES innovative grants was suggested to subsidize some programming.

A group will meet to discuss concerns with Council members about councilor expenses.

OTHER BUSINESS:

Kathleen Shaginaw reported that the successful spring PAGES event had 115 girls and 46 volunteers. There was a positive response to the survey of teachdone in November. PAGES is launching a web site. They have received \$1000 from the National Girls Collaborative. The American Association of University Women (AAUW) is having an event, Vision 20-20, at the Constitution Center on October 22. There will be two delegates per state. K.Thrush Shaginaw will be an ambassador from Pennsylvania. J. Cohen reported that the names of the 2010 Philadelphia Section ACS Fellows (J. Burke, M. The meeting was called to order by Chairman J. Summers-Gates at 4:15 PM.

COMMITTEE REPORTS:

Council Affairs (A. DeMasi): A full slate was present at the Boston National meeting, 11 councilors and one alternate. Guidelines for reimbursement of travel costs were discussed.

Finance, Budget and Audit (D. Cichowicz): Committee met and decided to open Schwab managed investment pool accounts. R. Ewing commented on the possibility of diversifying the fund. B. Golton reported that the investment goals for the Ullyot fund are preservation of capital plus income; they were

invested in bond funds with the former Investment Board. It was commented that Vanguard funds are cheaper; Schwab is only \$8.95 per trade. A motion was put forth to accept the decisions made by the Finance committee: 1. the Schwab accounts; 2. electronic transfer of funds; 3. J. Falcone and D. Cichowicz to act as agents. The motion was seconded by A. DeMasi and passed unanimously.

The discussion turned to the Ullyot Lecture — the question of whether there should be a and 2012 lecture. K. Thrush Shaginaw mentioned that we should have a lecture since 2011 is the International Year of Chemistry. 2012 was in question because of budget concerns surrounding the Philadelphia Section's hosting of the National Meeting. The conversation comments regarded location, cost of the award and other budget concerns. All agreed that the decisions surrounding the lecture need to be made by the Ullyot committee.

National Chemistry Week (V.Tortorelli): The meeting progressed to the Graduate School forum to be held on October 25 at Villanova University. An application has been made for a \$200 grant from National. V. Tortorelli reported that invitations had not been sent out yet to the graduate schools, which needs to be done soon. Budget issues surrounding forum then took place. The cost is estimated to be between \$700 and

\$800. The money to support this is in the National Chemistry Week budget.

D. Hausner may have updates to lists of undergraduate schools. He can also help out at Villanova.

K. Thrush Shaginaw reported that the materials for the PAGES program are in.

OFFICER REPORTS:

Chair (J. Summers-Gates): The advantages and disadvantages of moving to electronic voting for the Section election were discussed. A letter was received from the Nominating and Elections Committee; it appears that e-voting is not a cause for high concern. "Mail" in the bylaws may be interpreted as "e-mail." It was agreed that a postcard would be sent out to the entire membership. Crawford can help set up SurveyMonkey. Member number can be used for a unique ID. A motion was put forth to change the method of voting to electronic means using the current slate (K. Thrush Shaginaw). The motion was seconded by S. Miller. The motion was opposed by D. Cichowicz. The motion passed. The directions for voting will be in the October issue of the Catalyst.

Chair Elect (J. Tierney): Mentioned the need for an earlier meeting of the Ullyot committee; he suggested that there be two permanent representatives from the section to the committee.

He is working on modifying the section bylaws.

Secretary (M. Prushan): no report.

Treasurer (D. Cichowicz): It was mentioned that a large portion of funds were saved by the online version of *the Catalyst*. There is a tax payment from 2009 that was not paid which will probably result in a penalty and interest. A motion was made to accept the treasurer report; A. DeMasi seconded. The report was approved with two abstentions.

The Section extended a thank-you to Tony Addison for a donation.

OTHER BUSINESS:

K. Thrush Shaginaw reported that the website for the PAGES program is:

Alan Heldon volunteered to run for the board of directors. The board approved his nomination for the fall election.



624th Board of Directors' Meeting

Thursday, October 21, 2010 University of the Sciences Philadelphia, PA 19104

The meeting was called to order by Chairman J. Summers-Gates at 4:05 PM.

There were no minutes from the May or September meetings to approve.

COMMITTEE REPORTS:

Finance, Budget and Audit: Jim Falcone, Chair, gave a report on the current financial situation. First, the Finance, Budget and Audit Committee will take over the investment function of the former Investment Board of Trustees and present an annual report on Section finances. The committee now consists of Jim Falcone, David Cichowicz, Anne DeMasi, Bill Golton, Victor Tortorelli, John Tierney and

Cheryl Martin. They are working on a cash flow picture over the year. The goal is \$375,000 in total funds (capital, Ullyot and awards combined). Jim gave a Power Point presentation on the results of different investment styles and investment options. A moderate-conservative approach is recommended by the committee and ACS. K. Lysko was added to the committee.

V. Tortorelli pointed out that active oversight is not the goal so we should stick with a few funds, specifically Vanguard, if Jim Falcone is no longer available to manage the money. Tortorelli made a motion to allow the Finance, Budget and Audit Committee to invest in moderately conservative investments (Davis seconded). The motion was passed.

Tellers Committee: Tom Straub reported that the election deadline was extended because the postcards providing directions for casting ballots electronically were not mailed on time. A procedure for validating email addresses needs to be developed. The process of electronic voting needs to be considered an "experiment." There was also a discussion of how to handle members who change their email addresses or whose email address is different from the email filed with National.

OFFICERS' REPORTS:

Chair (Summers-Gates): reported that NCW posters are

coming in. The deadline is October 29 to send these to National. Summers-Gates will try to send posters by October 25. The Kids and Chemistry kits offered by National have been very popular and are being re-ordered.

Bob Gates and Judy Summers-Gates did a Career Day presentation at Renaissance Academy School which went very well.

The Graduate School Forum is ready for October 25. Nineteen schools have registered to participate. The Section has received a \$250 nanogrant to support the activity.

PAGES is all set for November 6. However Kathy needs more volunteers and has rejected 12 girls as the event is oversubscribed.

Bill Smith and Libby Harper moved and distributed 200 Merck Manuals to various local schools and the Delaware Valley Science Council. Bucks County science teachers received 70. Homes are needed for a few more manuals. D. Hausner requested that some be saved for the poster session in February 2011.

Summers-Gates is gathering information for the annual report. She would like to avoid the last minute marathon that occurred last year. Nominations for ChemLuminary Awards can now be submitted on line at any time. The Section needs to be

more proactive in highlighting its accomplishments. Other Sections get recognition for many of the things Philadelphia Section has been doing, e.g., distributing Merck Manuals.

Summers-Gates is trying to decide on a date for the December meeting and would like input from the Board as to which dates are best.

As part of IYC, the Philadelphia Science Festival will be held April 15-28, 2011. The web site for the festival is:

www.philasciencefestival.org.

Chair-Elect (J. Tierney): reported that he called a meeting for planning the Ullyot Lecture for 2011. The meeting had representation from all sponsors of the Ullyot Committee including Philadelphia Section ACS, CHF, USiP, U of PA, and Delaware Section ACS. Concern has been raised over the nature of the speakers selected for the Lectureship. The intent of Glenn and Barbara Ullyot was to have speakers who could address topics of interest to the general public and who could speak to science in the public interest and awareness. There is a commitment on the part of the selection committee to honor those wishes. Philadelphia Section, which controls the Ullyot endowment, can support travel expenses at reasonable rates for the speaker. These funds cannot be used for food or other expenses associated with a dinner or reception for the event. Chemical

Heritage Foundation will continue to host the lecture and support the reception. The next meeting for the Ullyot lecture is scheduled for August 2011. A request for funds needs to be made to the Budget, Finance, and Audit Committee in order that the funds for the Lecture-ship be placed in the 2011 budget and subsequently committed.

Tierney suggested that a timeline with due dates for specific responsibilities of officers be posted on the Section's web site. This will facilitate the completion of various duties of the Officers. It was pointed out that the Section Policy Manual lists the duties of the Section Officers. However, the manual has not been revised or updated in many years.

Treasurer's Report (D. Cichowicz): reported that several lines were added to the budget template. These include 4060 for the Ullyot Lecture, 4660 Transfer to Capital Fund, 4670 Transfer to Award Fund, and 4680 Transfer to Ullyot Fund. As of now the Section is approximately \$42,000 ahead of projection in spending for 2010. A few categories are overspent including 2030 Education that spent more on plaques in order to have plagues on hand and 2190 Social that overspent on the Drexel meeting. In addition, funds that should be shown as Program Committee (2150) expenses have not been moved out

of the Social Committee line item.

Tortorelli moved and Crawford seconded a motion to accept the Treasurer's Report. The motion carried. J. Falcone will be asking for detailed budget requests from committee and topical group chairs in time for a 2011 budget to be presented at the December meeting.

OTHER BUSINESS:

Councilor Reimbursement: Prior to the Treasurer's report, Cook made a request to the Board to be reimbursed for additional expenses she incurred in attending the Council meeting at the ACS National Conference in Boston in August 2010. Due to a clerical error, the summary sheet for Councilor Reimbursement was not included with the materials sent to Cichowicz. This resulted in a discrepancy of approximately \$490 less than Cook anticipated receiving. The error was not discovered until the reimbursement check was received. Cook, at Cichowicz' suggestion, made a formal request to the Board to be reimbursed for the additional \$490.04 of which \$367.53 will not necessarily be reimbursed by National. The remaining \$122.51 is the Section's responsibility. Cichowicz indicated that the expenses are allowable for reimbursement, and DeMasi, Chair of Council Affairs, recommended approving the request. Straub objected to approving the request as he feels this would set

a bad precedent in the event of a future similar request. Straub's position was that this would set precedent for any Councilor in the future to not follow procedures and ask the Board to make up any differences or discrepancies. Smith stated that this would not set a precedent as any request would have to be made to the Board and that the Board would always be able to decide whether or not to approve the request. After a lively discussion it was decided that Summers-Gates, DeMasi, and Cook would query National regarding procedures for revising and/or amending Councilor reimbursement requests and to ascertain if National would be able to reimburse Cook or the Section for the additional \$367.53. No formal motion was made, and the

item was tabled for the November meeting.

Strategic Planning Workshop: Ewing brought to the Board's attention the offer by National to work with the Section to organize and conduct a Strategic Planning Workshop. ACS would support the costs of their staff time, a consultant, and would provide all materials. The Section would be responsible for supplying a venue and for the food costs. Eight to twelve people are generally involved in the strategic planning session. Crawford reported he had been engaged in this process with Division Activities. Cook gave her perspective as a member of the ACS Leadership Advisory Board (LAB). The Board requested that more information

be obtained. Crawford and Ewing agreed to follow up and report back to the Board at the November meeting.

NOBCChE Regional Meeting: Davis distributed fliers and a tentative agenda for the Northeast Regional meeting of NOBCChE being held on November 5-6 at the University of Pennsylvania. Sharon Haynie will be the Keynote Speaker on November 5. Registration is free if received prior to October 21.

There being no other business, Summers-Gates moved to adjourn at 6:10 PM. The motion to adjourn was unanimously approved.

BOOK REVIEW—Alan Warren

Step-Growth Polymerization Process Modeling and Product Design, Kevin C. Seavey and Y.A. Liu. 744 pages, 6¹/₄ by 9¹/₂ inches, casebound, John Wiley & Sons, 2008. ISBN 978-0-470-23823-3, \$145 from John Wiley & Sons, Inc., 111 River St., Hoboken NJ 07030.

This book is based on a series of articles by the authors that appeared in *Industrial and Engineering Chemistry Research*, and addresses the step-growth or condensation polymerization processes used to make polyesters, polyamides, polyurethane, and similar materials. Much of the introductory text includes case studies, followed by fundamentals of simulating stirred tanks and plug-flow reactors, physical properties of polymers, phase equilibrium and mass transfer, reaction kinetics, enthalpy calculations (drying), and flowsheet simulation.

The next section of the book discusses the modeling of step-growth polymerization processes and properties using Polymers Plus by Aspen Technology of Cambridge, Massachusetts. The areas studied with this technology include Nylon-6, polyethylene terephthalate melt process simulation, and polycaprolactone and polyurethane polymerization.

The final section looks at advanced topics including fine-tuning models, multiscale modeling, and recent achievements and future challenges of polymerization process modeling and product design. An appendix lists the computer files pertinent to each chapter, and a glossary defines major terms used in the book.


