Mr. Andrew Devany is an Associate Scientist at International Flavors & Fragrances (IFF), where his work focuses on the development and scale-up of functional biopolymers for applications in the home and personal care industry. He earned his Bachelor of Science in Chemistry from Widener University, where he conducted undergraduate research centered on the green synthesis of substituted maleimides. This research was presented at the 2022 Spring American Chemical Society National Meeting during the Division of Chemical Education poster session.

Following his graduation in 2022, Mr. Devany joined IFF as a Research Associate and has since advanced through increasing levels of responsibility, contributing to applied research efforts that integrate reaction design, materials characterization, and process scale-up.

Mr. Devany's involvement with the American Chemical Society Philadelphia Local Section has been a central component of his professional development and service to the chemical community. He previously served as Secretary in 2024 and as Chair-Elect in 2025, during which time he supported the organization of technical programming, community outreach initiatives, and member engagement activities. ### **DEATHS**

**G. Hulings Darby**, chemist, in 2025 at age 85. He was retired from the Franklin Institute Research and Development Laboratories. He wrote about potential occupational hazards for the National Institute for Occupational Safety.

**Michael K. Kovacs**, retired chemist, July 11, 2025 at 75. He held positions with Vulcan Materials as a technician (1972-1973), Amchem Products as a chemist in the Steel Group Automotive Section (1973-1979), and Ashland Chemical as a supervisor in the new product development-specialty chemicals division (1979-1982). He then moved to Oakite Products as research projects and business manager (1982-1989), PQ Corporation as market development manager (1989-1998), and General Electric Water and Process Technologies. The last firm was taken over by Hercules where he was senior technical marketing project engineer (1999 until retirement). He was active in a Pennsylvania Civil War re-enactment group.

**Wallace L. Knepper**, retired chemistry teacher, October 14<sup>th</sup> at 87. He taught high school chemistry in Bucks County for 35 years. He was also a high school swimming coach and American Red Cross instructor.

**Evanda Gale Jefferson**, pioneering analytical and environmental black chemist, October 14<sup>th</sup> at 77. She served as chemistry lab assistant while attending Randolph-Macon College. Jefferson was a supervisor and then senior chemist at Gulf Oil Corp. She represented Gulf in magazine advertisements and at industry conferences and meetings. She was also a local and regional leader of the Association of Desk and Derrick Clubs of North America, an industry group for women in gas and oil. After retiring from Gulf, she was engaged in missionary work as a member of the National Missionary Baptist Convention.

**Richard John Hinchey**, retired inorganic chemist, October 18<sup>th</sup> at 87. He taught chemistry briefly at Purdue University and then worked in industry for Portland Cement, Union Carbide, Catalystics, Universal Oil Products, and PQ Corporation.

**Susan C. Saltzman**, retired chemist, October 23<sup>rd</sup> at 85. Following positions at Rohm and Haas and DuPont for 30 years, she served as president of Saltzman Consulting Services for 8 years. The firm specialized in shipment of hazardous materials. After retiring she was a volunteer with the Science History Institute and the Philadelphia Animal Welfare Society.

**INSTRUCTIONS FOR SUBMITTING A NOMINATION**

- 1) Nominators should provide a CV of the nominee showing education; employment and/or academic history; a list of publications, presentations, and patents; and a record of other accomplishments pertinent to consideration for this award.
- 2) One or two seconding letters (at least one of which should be from a person in an organization other than that of the nominee) should be requested in support of the nomination.
- 3) Nominators and seconders should be identified with addresses, e-mail and telephone numbers so that they can be contacted, if necessary, for additional information.
- 4) Unsuccessful nominees from previous years may be renominated. In fairness to the nominee, however, renominations must be accompanied by an updating of the nominee's biographical data and a list of accomplishments to make the nomination competitive. Unsuccessful nominees who have been considered three years in a row should not be renominated for the fourth year in succession without prior consultation by the nominator with the Chair of the Awards Committee.

- 2) **A current curriculum vitae or resume** that includes a list of the nominee's honors, professional activities, and additional evidence of service to the profession. This must be limited to no more than two pages, and the activities listed must have occurred within the past five years.
- 3) **A statement by the nominees** of not more than 500 words that describes the nominee's teaching philosophy or commitment to the profession.
- 4) **At least one, but not more than three, letters of support.** One letter, of no more than 400 words must be from the teacher's current principal or supervisor. Additional letters of support, of no more than 400 words, may be sent by colleagues, members of the ACS who are familiar with the nominee's achievements, or former students and parents of former students.
- 5) **The total nomination package should not exceed 30 pages.**

The 772<sup>nd</sup> Board Meeting of the Philadelphia Section, ACS, was called to order at 07:04 PM and Wei Gao read the ACS Code of Conduct. (Action: Review with National)

**Roll Call**

Roll was taken, a quorum was present, and the meeting began at 7:01 PM.

**Approval of Meeting Minutes – tabled until the October meeting**

**Officers' Reports:**

**Chair – Wei Gao – Get slides**

Thanks to the Communications Committee for their efforts (*Catalyst*, other social media platform. June meeting was CCN event. The event was well-received.

Senior Chemists event (50-, 60-, 70-year members.) The September 18<sup>th</sup> event will be a webinar titled “Transformative Natural Polymers” and the speaker will be Dr. Qiong Yuan. A YCC Poster Event will take place on September 26<sup>th</sup>. YCC Co-Chairs are Dr. Kunyu Wang and Dr. Andres Vasquez. On October 4<sup>th</sup>, there will be two events: PAGES™ and the SHI Museum tour and career program. Chair Gao gave special thanks to S. Haynie for creating the pamphlet in memory of our dear colleague Kathleen Shaginaw honoring her many years of selfless service to our Section.

**Immediate Past – Matt Irwin –** M. Irwin is working on the election slate. (See slide) He noted that we are looking for Chair-Elect 2026 (3-year term); Secretary (2-year term); Nominations due to Matt on September 25<sup>th</sup>. He shared the list of Directors who are terming out. Alternate Councilors can run for Council. V. Tortorelli is filling K. Shaginaw's unexpired term as councilor. It is not necessary to replace K. Shaginaw term on the Board per the Section bylaws. Bios will be due to Steve Fleming by the end of September. The Board will need to approve the slate by email. Elected members need to be certified with National before the end of the year.

Ullyot Lecture Committee – Phila ACS event. M. Irwin shared the following on slides:

**History & Context**

- The Ullyot Lecture is a **Philadelphia Section ACS event** (per Glenn & George Ullyot) where the selection committee is co-chaired by the chair-elect of Philly ACS and the President of the Science History Institute (SHI).
- Sponsorship includes Delaware ACS, U Penn, St. universi's University (formerly USciences), and the Science History Institute (formerly CHF).
- For decades, the Philadelphia Section has had a **permanent representative** (Jim Falcone → Deb Cook).
- Section minutes (2013) and work manuals confirm this practice, though bylaws used today omit it.

**Current Concern from SHI (2025)**

- SHI questions the Section's “extra” voting role since **not explicit in current bylaws**.
- They propose shifting to **non-voting or term-limited status**.
- Issue was first raised in 2023 with intent to revise bylaws; **no bylaw revisions were adopted then**.
- The matter has now **resurfaced in 2025**.

## Philadelphia Section Position

- There is **clear documentation and precedent** for the Section's permanent representative — a **de facto state** that has guided practice for over a decade.
- No unilateral changes —**all sponsors must agree** before bylaws can be revised.

## Path Forward

- Affirm the **de facto state** as valid precedent, despite omission in bylaws.
- Recognize the need for **updated bylaws** that align with established practice and prevent future disputes.
- Ensure any revisions are **consensus-based**.
- Maintain stability for 2025 while pursuing clarity for future years.

S. Haynie may have a conflict of interest as she serves on SHI Board; she supports Matt's proposal; stand by the original intent of the Ulyot family.

V. Tortorelli mentioned that we are only ones that have two at the table. Perhaps we should have a non-voting member though it has been by consensus. D. Cook noted that SHI President Permanent member is on committee, chairs and does not vote. She shared the selection process recommended that suggestions for awardees be sent to Chair-Elect Devany. There exists a document (work manual etc) that states that the other entities are designated by their department chairs. They can have an additional member if they so choose. Purpose of permanent to have consistency as local section chair-elect rotates each year. Penn has two votes, two different departments. St. Joesph's University and Delaware Section have one vote. D. Cichowicz shared the history. SHI is default venue but can be adjusted at the discretion of the committee. V. Tortorelli mentioned that we have copies of the document that Glenn Ulyot signed. We are obligated to use the proceeds, not the principal to fund this lecture. This document needs to be reviewed. Recognize that CHF does a wonderful job hosting the event. Budget and Finance has a separate fund specific to this endowment. It does not cover food and beverage. It generally covers travel costs. The guidelines are from 1996. D. Cook to send document to Chair Gao.

Communications Challenges and Path Forward. M. Irwin shared the following:

### Current Issues

- **Catalyst deadlines:** Content due **15<sup>th</sup> of prior month** (e.g., Sept issue → Aug 15).
  - Deadlines often missed; editors must chase content individually.
  - Would be stronger if the **whole Communications Committee drove content collection**.
- **Website:** Not updated prior to Fall meeting — likely linked to missed *Catalyst* inputs.

### Context

- Ongoing concerns with **timeliness, responsiveness, and coordination**.
- Prior attempt in 2024: I developed a **checklist with Robert (admin)** to ensure consistency.
  - **Not adopted in 2025**, leaving processes unstructured.

### Path Forward (Recommendation)

- Recommend establishing a **standard communications calendar** across *Catalyst*, website, email, and polls.
- Recommend ensuring accountability is **committee-driven**, not on individuals.
- As I term off as Immediate Past Chair, I offer to take a **more active role in the Communications Committee** to support improvement.

**Chair-Elect – Andrew Devany** – A. Devany reported that Dr. Spiridoula Matsika from Temple University will be the recipient of the 2025 Philadelphia Section Award. The event will take place Thursday, October 23<sup>rd</sup>, 5 - 8 PM at Temple reception will run from 5:00 PM to 6:00 PM, the ceremony/lecture from 6:00 PM to 7:00 PM, and dinner would follow on from there. He commented that Ann Valentine has been a major help assisting with reserving the space, get the parking passes, and work on the catering exception for He requested for preemptive approval of \$1,000 to cover initial dinner costs and will charge tickets for dinner. He also requested another \$500

to cover reception or split cost with Temple. A. DeMasi/V. Tortorelli mentioned that there should be funds in the Program Budget to cover whatever is needed.

**Secretary** – Anne DeMasi – no report

**Treasurer** – Ivona Macor - checks to Councilors have been mailed and should arrive next week. 12 seed students in 8 lab. Ivona warned us to be wary of spam emails asking for money. Ivona received a letter from the IRS (University of Penn), needs to be addressed. We are missing a credit card. Ivona suggests a PO Box for our correspondence.

Motion to approve Treasurers report - seconded by V. Tortorelli, all in favor except C. McInnis abstained.

## **Council Affairs:**

D. Cook reported that we had a full complement of Councilors at the DC meeting with 6 attending in person and 4 virtually. Councilors need to submit reimbursement vouchers with receipts to Ivona. Alcohol will not be reimbursed. Cook also reported that she, Macor, Tortorelli and D. Cichowicz met to discuss Councilor reimbursement procedures and how to deal with unexpended funds from the ACS and Section allotments. D. Cichowicz will work up an outline. The group will reconvene to discuss before bringing recommendations to the Board. Directors were asked to submit questions or suggestions to D. Cichowicz via email.

## Other Committees

### YCC

Kunyu Wang reported that YCC is hosting an event at UPenn on September 26. It will include a speaker and career workshops. Details can be found on the Section website and in the Catalyst.

### Minority Affairs

Greglynn Gibbs reported that the committee now has officers and members. They are planning an event on Oct 25 in conjunction with a cancer organization. It is a run with a gathering at the Art Museum Rocky Steps and fountain. Other plans are in the works including a virtual speaker series and Sr. Chemists podcast.

### Communications Committee

Lee Hoffman reported on the *Catalyst* delay and that the deadline was the 20<sup>th</sup> of the prior month. The Committee is working on a workflow document. The Committee will work with Robert Mertz, Section Admin, to request his involvement in reminding people to submit Catalyst items.

Matt Irwin reported he is working on the workflow document and will present in the future. There will be a process for Board members to access distribution lists via the website. This will be a secure site and users will have to request access.

Georgia Arbuckle brought up need for someone in addition to Marge Matthews to access MailChimp for Catalyst distribution. As an aside Marge is currently in Bryn Mawr Hospital. D. Cook also reported that Wei Gao was asked to distribute Councilor Talking Points to the Board members. PAGES™ is in need of additional participants.

The meeting was adjourned at 8:28.

## Roll Call

Roll was taken, a quorum was present, and the meeting began at 7:03 PM.

## Approval of Meeting Minutes

Approval of the prior month's minutes was deferred, as updated revisions were not ready for presentation. The amended minutes will be circulated by email for review and approval.

## Officers' Reports

### Chair – Wei Gao

Wei provided an overview of recent Section activities and updates:

#### Recent Items:

- The *Catalyst* for November has been published.
- October event highlights were previously covered at last month's meeting, but additional detail and individual acknowledgments appear in the Chair's Message on the website.
- The PAGES™ program has undergone a rebranding, shifting from "Philadelphia Area Girls Enjoying Science" to "**Philadelphia Area Girls Exploring Science**" to better reflect discovery-oriented goals.

#### Event Recaps:

- Strong turnout and excellent scientific programming were noted at the recent October Section meeting. Special thanks were extended to Ann and Andrew for arranging logistics and managing the event.

#### Upcoming Events:

- **Transformative Natural Polymers (CCN) Webinar** to be held next Thursday. This event is part of the ongoing national initiative co-chaired by Wei.
- **30<sup>th</sup> Anniversary CCN Celebration** will be held on **December 9<sup>th</sup>** at Arcadia University's Grey Towers Castle, including a 6:00 PM tour and a 6:30 PM program.

#### Board Social:

- A Doodle poll for the December Board Social showed **December 11<sup>th</sup>** as the date with the highest availability. Members should plan tentatively for this date.

Wei then yielded the floor to the Immediate Past Chair and Chair-Elect.

### Immediate Past Chair – Matthew Irwin

Matt reviewed updates related to the **Ullyot Public Affairs Lecture** and the Section bylaws:

- He met with the Science History Institute to finalize governance document updates.
- Proposal: Add a **permanent Philadelphia Section representative** to the Ullyot Governing Committee, appointed by the Board for renewable 3-year terms, to preserve institutional memory and ensure long-term continuity.

### Chair-Elect – Andrew Devany

Andrew outlined goals and ongoing planning for his Chair-Elect year:

#### Administrative Priorities:

- Develop a more formal, comprehensive Chair/Chair-Elect handbook to improve knowledge transfer and succession planning.
- Establish a centralized, well-organized Google Drive repository for committee and officer documents.
- Advance completion of Section bylaws and D&O insurance implementation.

- Strengthen involvement of early-career chemists and prospective members.

- Speaker invitations are being coordinated for mid- and late-year section meetings.
- Andrew hopes to organize a **food and toy drive** aligned with the 2026 holiday season.

## Committee Reports

### Tellers Committee – Steve Fleming

Steve reported on election statistics, noting:

- This year had the **highest voting participation in a decade**.
- The total number of eligible voters has declined over time, but repeated reminders significantly improved turnout this cycle.

### Election Results:

#### Chair-Elect (2026):

- *Greglynn Gibbs* elected.

#### Secretary (2026–2027):

- *Matthew Irwin* elected.

#### Board of Directors (2026–2028):

- Five directors elected, with the correction that *Rob Dyer* should replace Matt Irwin due to Matt's election as Secretary.

#### Councilors (2026–2028):

- *Amy Brown, David Cichowicz, Deborah Cook* elected.

#### Alternate Councilors (2026–2028):

- *Anne Rowley, Jim Murray, Anthony Addison*  
(Final adjustments pending review of current-year alternates.)

Steve encouraged outreach to candidates who were not elected but expressed interest, suggesting that their involvement in committees would strengthen the Section.

## CCN – Youwen Xu

Youwen shared details for the **CCN 30<sup>th</sup> Anniversary Celebration**:

- Event will take place on **December 9<sup>th</sup>** at Arcadia University's Grey Towers Castle.
- Program includes a tour, keynote presentations, and recognition of long-time volunteers.
- Attendees will be invited to contribute ideas for CCN's development over the next 30 years.
- The event is posted on the website and will appear in the December *Catalyst*. Registration is now open.

## **Delaware Valley Chromatography Forum (DVCF)**

Wei presented an update on discussions with the **Delaware Valley Chromatography Forum** about joining the Philadelphia Section as an official topical group.

Key points:

- DVCF is an **active regional chromatography organization** with a strong history of technical programming.
- They host an **annual April symposium**, heavily attended by students, early-career chemists, and local industrial scientists.
- Their programming aligns with ACS goals:
  - Enhances student engagement and mentoring opportunities.
  - Broadens industrial networking and professional development within the Section.
- Adding DVCF could help revitalize topical-group activity, especially compared to several inactive groups currently listed.

Matt noted that the bylaws will be reviewed to determine the **formal process** for adding new topical groups, and the Board will revisit the recommendation later.

## **Additional Updates from Chair – Wei Gao**

Before closing, Wei shared additional context related to the **Transformative Natural Polymers (CCC)** initiative:

- The CCC was established through a 2024 ACS grant proposal and focuses on balancing **performance, cost, waste reduction, sustainability, and health considerations** in natural polymer innovation.
- The initiative is currently supported by six ACS technical divisions, including:
  - POLY
  - AGFD
  - ENVR
  - CARB
  - CELL
  - And a newly added division that recently voted to join
- Work includes:
  - A national website and shared digital resources
  - Monthly webinars hosted through the Philadelphia Section platform
  - Collaboration between academic and industrial scientists in sustainable polymer chemistry

Wei offered to present the full slide deck at a future meeting upon request.

No additional comments were raised.
